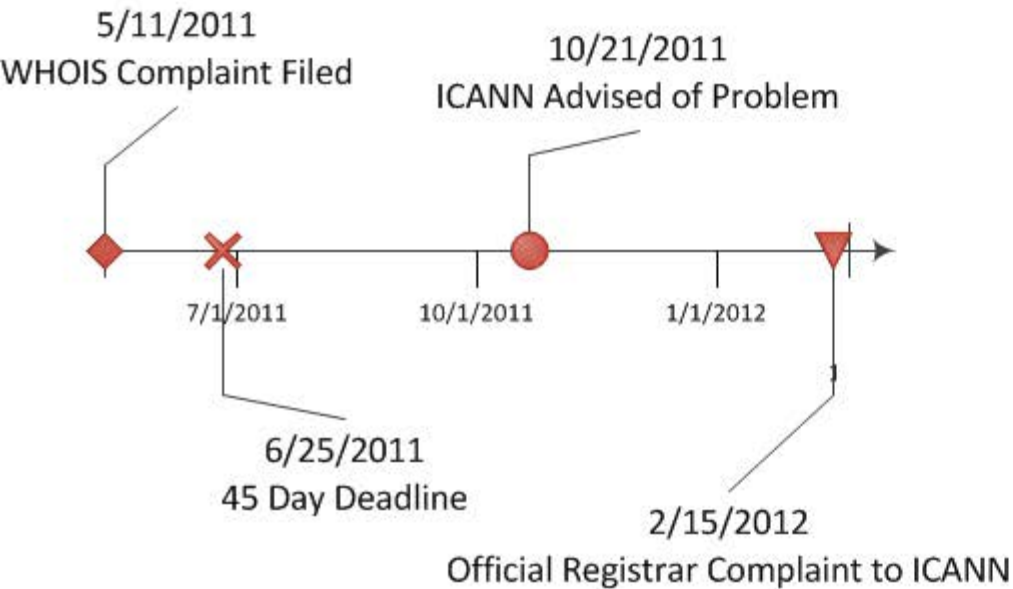

## KnujOn Process Brief

The domain indicated below was reported to KnujOn.com as being advertised in unsolicited email messages or in connection with other illicit Internet activity. Inspection of the domain indicates it is used to advertise and sell illicit pharmaceuticals. These sites frequently offer drugs without prescription or age verification from unlicensed and unauthorized sources. Attempts to contact the registrant of record through the WHOIS failed for the reasons cited. At the end of the 45-day WDPRS lifecycle the domain in question was still online with the same content and the WHOIS was not updated. In the interest of providing context and background, an example of the illicit content is provided.

The complaint details refer to a domain which is currently registered with the email "admin@fortextltd.com"

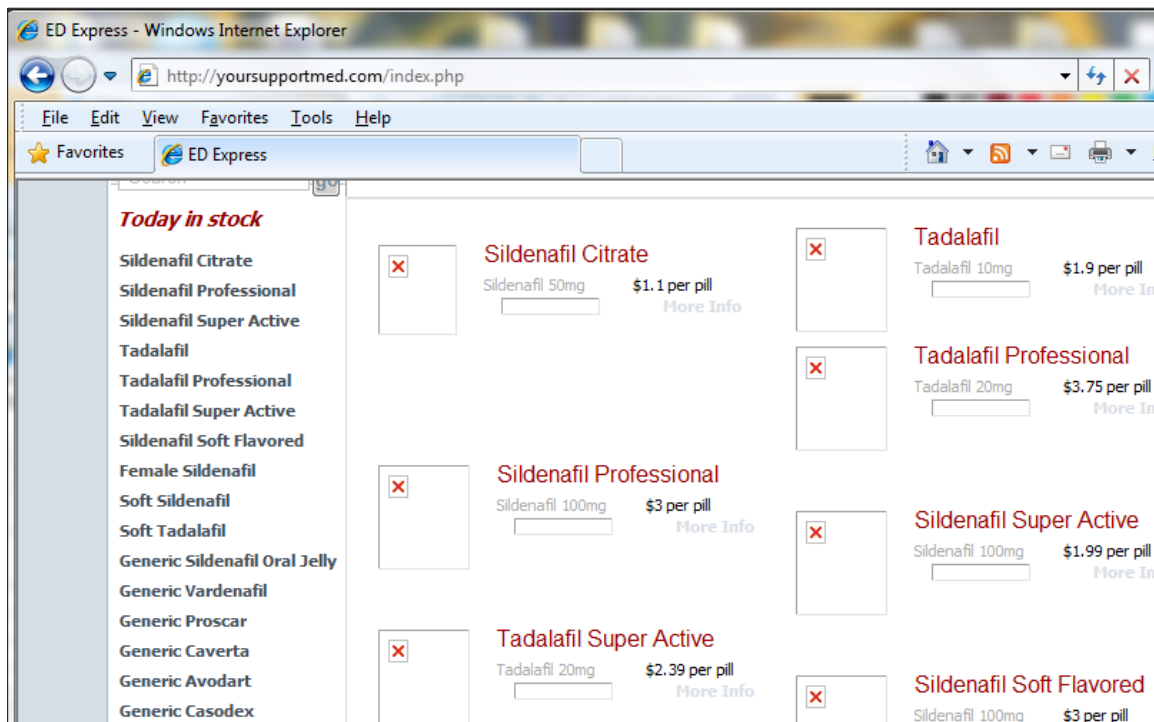
